I, the undersigned, know the inherent risks offered by the YMCA of Central New Mexico, understand those risks, appreciate those risks, and agree to assume responsibility for those risks.

INDEMNIFICATION AGREEMENT: I, the undersigned, shall defend, indemnify, and hold harmless the YMCA of Central New Mexico, representatives, management, employees, volunteers, agents, and sponsors from any and all claims, demands, losses, damages and liabilities for indemnities, contribution or otherwise, with respect to any damage and/or injury, of any type, arising from my participation in the swimming programs.
